## **GUIDELINES** and additional information

- All entry forms are the responsibility of the rider/owner and must be completed in full and include all fees. Any incomplete entry forms will not be processed.
- 2 IOM Dressage competitions are run under the rules of British Dressage which can be found in full at http://www.britishdressage.co.uk/rules
- All those taking part in a competition, etc or parent/guardian of a junior competitor, arranged by the IOMDG should have full insurance cover for their animals and public liability. Policies should be carried by competitors and should be presented to any IOMDG official at any time during the show should they be requested.
- 4 Ballakaneen Dressage does not accept any responsibility for any accident, loss, damage, injury or illness to horses, owners, riders, spectators, land or any other person whatsoever however caused at this event.
- Ballakaneen Dressage has been recognised as an appropriate venue and been authorised by a suitable representative of British Dressage. A written risk assessment has been conducted for this show.
- At designated shows additional prizes and/or rosettes will be given for best scores for seniors, juniors, horses bred on the island, affiliated riding club member, side saddle, veteran horse/pony, veteran rider, Young Horse and Mountain and Moorland (pure or part bred) entrants. Please mark the appropriate boxes on the entry form to apply
- 7 Unscheduled unaffiliated class, including freestyle and/or freestyle to music may be requested.
- 8 Should any competitor need to withdraw it is the competitor's responsibility to ensure that the organisers are informed using the designated telephone number see web site.
- 9 Instructions given by any officials on the day, either verbally or in writing, must be adhered to.
- Where a freestyle to music class is scheduled the music should be handed to the organiser at least one hour before on a CD clearly labelled with the competitor's name and number, plus the time of the test.
- 11 Competitors must attend official prize givings (in full show gear), or ensure that they are represented. Failure to attend may entail the forfeiture of prize money, rosettes and other rewards.
- Any competitor who wishes to receive their test sheet but is unable to collect it on the day should provide the show organisers with a SAE.
- Objections may only be made by the owner, their agent or the rider of a horse taking part in a competition. Objections must be made to the Secretary of the Competition in writing and accompanied by a deposit of £25, not later than one hour after the final results are put onto the scoreboard. The Senior Dressage Judge present should adjudicate whenever possible. If this is not possible the objection should be referred to the Dressage Office for consideration by the Disciplinary sub-committee. The deposit is forfeited unless the objection is upheld or it is decided that there were good and reasonable grounds for the lodging of an objection. Where an objection is related to a scoring error, the competitor must notify the organiser within 24 hours of the result being published, if a change needs to be made or a possible qualification registered.
